WHEREAS, H. A. Schreck the contractor who services the Town’s generators, recommended that the Town of Hyde Park Highway’s generator was in need of repair as soon as possible since the radiator of said generator had outlived its useful life; and

WHEREAS, H. A. Schreck presented to the Town a quote in the amount of \$4,914.53 to repair said generator; and

WHEREAS, the Town’s Procurement Policy states that if a service is to cost more than \$3,000, three written proposals are required after obtaining Town Board approval; and

WHEREAS, both the Town Supervisor and Town Comptroller are in agreement that said repairs need to be done as soon as possible and find H. A. Schreck’s quote to be reasonable and acceptable; and

WHEREAS, it would be in the best interest of the Town to override the Town’s Procurement Policy in this instance and accept the proposal of H.A. Schreck since time is of the essence for the repairs of the Hyde Park Highway generator.
