**RESOLUTION 5:17 – 1 OF 2021**

**RESOLUTION ORDERING REPAIR AND/OR REMOVAL OF STRUCTURES OWNED BY ADAM H. KRUKOWSKI AND THE LATE ALICE KRUKOWSKI PURSUANT TO §40-9 OF THE TOWN CODE**

**WHEREAS**, Richard Longendyke, Deputy Building Inspector of the Town of Hyde Park, filed a report in writing with the Town Board, on or about March 10, 2021 containing his findings and recommendations concerning certain structures situated on the premises located at 563 N. Quaker Lane, Hyde Park New York, Tax Map No. 6266-19-654134 owned by Adam H. Krukowski and the late Alice Krukowski, in which said Deputy Building Inspector stated his opinion that the structures are unsafe and present a danger to the health, safety, and welfare of the public and that the property owner should be ordered to repair and/or remove these structures in accordance with the requirements of §40-9 of the Town Code; and

**WHEREAS**, the Hyde Park Town Board, after reviewing said report, and after hearing the Zoning Enforcement Officer with regard thereto at a meeting of the Town Board held on May 3, 2021, and having duly deliberated upon the same and having determined that said report warrants the repair and/or removal of said structures in accordance with the requirements of §40-9 of the Town Code, Ordered:

- (a) That notice be given to Adam H. Krukowski and the late Alice Krukowski, the reputed owner of the property and the structures which are located thereon at 563 N. Quaker Lane, in the Town of Hyde Park, in the form required by §40-9 of the Town Code;
- (b) That said notice be served on the said property owners, in the manner required by §40-9(E) of the Town Code;
- (c) That said notice ordered the repair or the demolition and removal of the said structures on the said property from the premises be commenced within thirty (30) days of service of said notice and to be completed within sixty (60) days thereafter;
- (d) That a public hearing be scheduled on May 3, 2021 at 6:05 p.m. at the Town of Hyde Park Town Hall, located 4383 Albany Post Road, Hyde Park, New York; and
- (e) That the Attorney to the Town and Deputy Building Inspector prepare said notices of said public hearing and arrange for service of the same, in accordance with the requirements of §40-9(E) of the Town Code.
- (f) Directed the Town Clerk to file a copy of the Notice served as provided herein in the office of the Dutchess County Clerk and the Town Clerk; and

**WHEREAS**, the Town Board had received confirmation that the said notices were duly served on the said property owner as required by §40-9(E) of the Town Code; and

**WHEREAS**, the Town Board opened the public hearing on May 3, 2021 at 6:05 p.m. pursuant to said notice and closed the public hearing on said date.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board, after hearing testimony at the said public hearing and after reviewing all of the documentation associated with said violation, determines that said premises are in such condition that it is accessible to, and an object of attraction to minors under the age of 18, as well as to vagrants and other trespassers and is or may become a place of rodent infestation, and presents a danger to the health, safety, morals, and general welfare of the public and is unfit for the purpose for which it may lawfully be used; and

**BE IT FURTHER RESOLVED**, that the employees or officers of the Town of Hyde Park and/or a private contractor retained by the Town, are hereby authorized to enter onto said property and to bring the property into compliance with the standards of §40-9 of the Town Code by removal and demolition of any such structures and/or buildings and structures on the said properties; and

**BE IT FURTHER RESOLVED**, that all expenses incurred by the Town in connection with the proceedings to demolish and remove the unsafe building and/or structures shall be assessed against the land on which such building is located and shall be levied and collected in the same manner as provided in Article 15 of the Town Law for the levy or collection of a special *ad valorem* levy; and

**BE IT FURTHER RESOLVED**, that a copy of this Order shall be served upon said property owner in the manner required by §40-9(E) of the Town Code and posted upon the premises and this Order shall be filed in the office of the Dutchess County Clerk and the Town Clerk.

### **RESOLUTION ACCEPTING AMENDED VERSION OF LOCAL LAW NO. E OF THE YEAR 2021 IMPOSING A SIX-MONTH MORATORIUM ON THE PROCESSING AND APPROVAL OF APPLICATIONS FOR RURAL EVENT VENUES PURSUANT TO CHAPTER 108, §108-28, et. seq. OF THE TOWN CODE AND RE-OPENING THE PUBLIC HEARING PROCESS**

**WHEREAS**, the Town Board had determined, upon the advice of its Zoning Administrator, that there may be some ambiguity in Chapter 108, §108-28, et. seq., of the Town Code with regard to Rural Event Venues and that there may be other sections of the said section of the Town Code which may be in need of amendment; and

**WHEREAS**, the Town Board had determined that the Rural Event section of the Town Code needs to be reviewed and possibly amended, as appropriate; and;

**WHEREAS**, the Town Board directed its planning consultant and the Attorney to the Town to review the local law and provide recommendations for amendments to that section of the Town Code; and

**WHEREAS**, the Town Board has determined that such moratorium law is a Type II action, exempt from SEQRA review; and

**WHEREAS**, the Attorney to the Town prepared a six-month moratorium law providing for the moratorium on the processing and approval of applications for Rural Event Venues pursuant to Chapter 108, §108-28 et. seq. of the Town Code; and

**WHEREAS**, the Town Board determined that the enactment of the moratorium was required to provide the necessary time for the Town Board to review and to amend its Code with regard to Rural Event Venues; and

**WHEREAS**, the Town Board accepted Local Law No. E of the Year of 2021 entitled: "A Local Law Enacting a Six-Month Moratorium on the Processing and Approval of Applications for Rural Event Venues Pursuant to Chapter 108, §108-28 et. seq. of the Town Code" and scheduled a public hearing on said local law for May 3, 2021 at 6:05 p.m. and opened and closed the public hearing on said date; and

**WHEREAS**, the Town Board directed the Town Clerk to publish notice and provide such other notice of said public hearing as may be required by law; and

**WHEREAS**, the Town Clerk was directed to forward a copy of said local law to the Town of Hyde Park Planning Board and to the Dutchess County Department of Planning and Development, as may be required by law, for their comments; and

**WHEREAS**, the Attorney to the Town, based upon further review of the original version of the proposed law, and after receiving comments from the Dutchess County Department of Planning and Development, has amended the Local Law to include, in relevant part, certain language concerning the length and details of the moratorium and a hardship waiver; and

**WHEREAS**, the Local Law as amended has been provided to the Town Board members and reviewed by the Town Board.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board hereby accepts the amended version of the proposed moratorium law, and re-opens the public hearing for June 7, 2021 at 6:05 p.m.; and

**BE IT FURTHER RESOLVED**, that the Town Board hereby directs the Town Clerk to provide such posting and notice of said public hearing as required by law; and

**BE IT FURTHER RESOLVED**, that the Town Clerk is hereby directed to forward a copy of this Resolution with the amended moratorium law to the Hyde Park Planning Board and Dutchess County Department of Planning and Development; and

**BE IT FURTHER RESOLVED**, that per the Governor's Executive Order, the meeting and public hearing will be held virtually with no gathering at the Town Hall and will be live streamed on the Town of Hyde Park's You Tube channel with the following link to review:

**TOWN OF HYDE PARK**

**LOCAL LAW NO. E OF THE YEAR 2021**

**A LOCAL LAW ENACTING A SIX-MONTH MORATORIUM  
ON THE PROCESSING AND APPROVAL OF APPLICATIONS  
FOR RURAL EVENT VENUES PURSUANT TO  
CHAPTER 108, §108-28, et. seq., OF THE TOWN CODE**

**BE IT ENACTED** by the Town Board of the Town of Hyde Park as follows:

**SECTION 1. LEGISLATIVE INTENT.**

The Town of Hyde Park adopted Chapter 108, Chapter 108-28, et. seq., of the Town Code by Local Law No. 10 of 2016 in or about November 28, 2016. It has come to the attention of the Town Board through the Town's Zoning Enforcement Officer that there may exist some ambiguities in the said Code provisions with regard to issues such as whether a rural event venue can be established in a newly constructed building or other structure. The Town Board has determined that there are other provisions of the rural event venue Code provision that may be in need of modification or amendment. The Town Board has determined that a six-month moratorium on the processing and approval of rural event venues is necessary in order to give the Town Board the necessary time to review the Code with its Town Planner and Attorney to the Town and determine if amendments to the Code are in the best interests of the Town and its residents. It is anticipated that the process will not take longer than six months. The enactment of this local law is designed to protect the health, safety and welfare of the Town of Hyde Park and its residents and maintain the status quo to allow the Town to study and make the required amendments to the Code for rural event venue facilities.

**SECTION 2. MORATORIUM.**

A. A moratorium is hereby imposed from the effective date of this Local Law for a period of six (6) months on the processing and/or approval of all applications for erection, construction, reconstruction, expansion, changing, repairing, or structurally altering any rural event venue facilities pursuant to Article 108, Section 108.28 et. seq. within the Town.

B. The Zoning Administrator, Building Inspector and the Planning Board shall not consider applications for site plan review or special permit approval for rural event venues within the scope of this moratorium for the terms of this moratorium.

C. No building permit shall be issued pursuant to the Town of Hyde Park Zoning Code for construction of any rural event venue facility for the term of the moratorium.

### **SECTION 3. HARDSHIP WAIVER.**

A. The Town Board may waive the provisions of the moratorium upon the application of an owner of property on which a rural event facility would have been a permitted principal, special permit or accessory use in the absence of this moratorium, provided that the applicant can demonstrate and the Town Board finds, based upon competent evidence and taking into account the impact of the relief on the health, safety, welfare, open space, rural character, scenic viewsheds and natural resources of the Town: (i) the application of this moratorium to the applicant's property will constitute an unjust result and cause the applicant substantial economic hardship; (ii) the proposed use of the property will not harm the public health, safety, and welfare; and (iii) the proposed use of the property is consistent with the Comprehensive Plan of the Town of Hyde Park and compatible with the existing land use in the immediate vicinity of the property. This application must comply with all other aspects of the Town of Hyde Park Code.

B. Upon submission of a written application to the Town Clerk by the property owner seeking a hardship waiver to this moratorium, the Town Board shall, within sixty (60) days of the receipt of such application, schedule a public hearing. Public notice of such hearing shall be given at least five (5) days prior to the date thereof in the official newspaper of the Town. At said public hearing, the property owner, and all other parties wishing to present evidence with regard to the application shall have an opportunity to be heard, and the Town Board shall within thirty (30) days of the close of said public hearing render its decision either granting, with, or without, conditions, or denying the application.

### **SECTION 4. STATEMENT OF AUTHORITY.**

This Local Law is authorized by the New York State Constitution, Article IX, §2; the provisions of the New York State Municipal Home Rule Law (MHRL); the provisions of the Statute of Local Governments; all relevant provisions of the Town Law of the State of New York; the laws of the Town of Hyde Park and the general police powers vested in the Town of Hyde Park to promote the health, safety, and welfare of residents and property owners within the Town.

**SECTION 5. SUPERSESSION OF TOWN LAW.**

Pursuant to the authority granted in the Municipal Home Rule Law, §1(ii)(b)(3) and in accordance with §22(1) of the MHRL, this Local Law supersedes §§267-a, 267-b, 274-a, 274-b, 276, 277 and 278 of the New York State Town Law.

**SECTION 6. PENALTIES FOR VIOLATION.**

In the event of a violation of this law, the penalties shall be those listed in the Town Code of the Town of Hyde Park for Zoning Code violations.

**SECTION 7. SEVERABILITY.**

The invalidity of any word, section, clause, paragraph, sentence, part, or provision of this Local Law shall not affect the validity of any other part of this Local Law, which shall be given effect without such part or parts.

**SECTION 8. EFFECTIVE DATE.**

This local law shall take effect immediately upon filing in the Office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

**RESOLUTION 5:17 – 6 OF 2021**

**RESOLUTION AUTHORIZING THE TOWN OF HYDE PARK TOWN SUPERVISOR TO ACCEPT A REDUCED RESTORATION BOND WITH REGARD TO THE INN AT BELLEFIELD PROJECT**

**WHEREAS**, on January 3, 2018, by resolution #2017-04D (the “Resolution”), the Planning Board granted T-Rex Hyde Park Owner LLC conditional site plan approval for Sub-Phase 1-A of the approved Concept Plan for the St. Andrew’s Planned Unit Development, consisting of a 5-story, 133 guest room hotel located near the intersection of Albany Post Road and West Dorsey Road, tax parcel no. 6163-01-131849, together with the first phase of a proposed wastewater treatment plant and other infrastructure improvements to serve the hotel (collectively, the “Project”), as depicted on a site plan entitled “Inn at Bellefield” prepared by Chazen Engineering dated June 30, 2017, last revised December 15, 2017, and architectural elevations prepared by ZHA Architects, dated September 6, 2017 (the “Approved Site Plan”); and

**WHEREAS**, condition 25 of the Resolution required submission of a Site Restoration Bond in the amount of \$50,000 to cover the cost of erosion work in the event that the project was abandoned during the course of construction; and

**WHEREAS**, the conditions of approval as set forth in the Resolution were modified by the Planning Board on June 20, 2018, April 17, 2019 and August 7, 2019; and

**WHEREAS**, the applicant has partially completed the restoration with the exception of a wetland repair where the utilities cross the entrance just north of the primary entrance on Route 9; and

**WHEREAS**, the applicant has requested that the Site Restoration Bond be reduced; and

**WHEREAS**, the Town Engineer has reviewed said request, and by memorandum dated April 2, 2021 has indicated that he has no objection to the bond being reduced to \$10,000; and

**WHEREAS**, the Planning Board by Resolution dated April 7, 2021 has recommended a reduction of the Performance Guaranty to \$10,000.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board hereby authorizes the Town Supervisor to accept a reduced Site Restoration Bond for the Inn at Bellefield project in the amount of \$10,000.

**RESOLUTION AUTHORIZING THE TOWN OF HYDE PARK TOWN BOARD TO APPROVE THE NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION 2020-2021 MS4 PERMIT ANNUAL REPORT**
