RESOLUTION AUTHORIZING THE TOWN OF HYDE PARK POLICE DEPARTMENT TO SUBMIT NUNC PRO TUNC THE DUTCHES COUNTY 2021-2022 MUNICIPAL INVESTMENT GRANT PROGRAM FOR BODY WORN CAMERAS FOR POLICE REFORM

WHEREAS, on June 12, 2020, Gov. Andrew M. Cuomo signed Executive Order 203, requiring each local government in N.Y. State to adopt a policing reform plan that will maintain public safety while building mutual trust and respect between police and the communities they serve; and

WHEREAS, the Hyde Park Police Department in conjunction with the Town Board and Supervisor have developed and approved the Hyde Park Police Reform Plan, which includes the acquisition of body worn cameras, to comply with Executive Order 203; and

WHEREAS, the County has set aside approximately \$1 million to support local initiatives that champion community priorities and improvements for municipalities and residents. The Municipal Investment Grant Program will fund projects that enhance and improve general municipal operations including the purchase of operating infrastructure; and

WHEREAS, the Town of Hyde Park would like to utilize this opportunity to apply for funding to acquire body worn cameras for the Town of Hyde Park Police Department, which will enhance the accountability and transparency of the police department in their interactions with the community; and

WHEREAS, the Town of Hyde Park Police Department would additionally have added protections through neutral 3rd party witness in the form of body worn cameras, and increased efficiency with the Dutchess County District Attorney Office in providing evidence and discovery; and

WHEREAS, all applications had to be submitted no later than Friday, May 28th, 2021 which was prior to the next regularly scheduled Town Board Meeting.

NOW THEREFORE BE IT RESOLVED, that the Town of Hyde Park Town Board does hereby authorize the Town Supervisor to submit nunc pro tunc an application for the 2021-2022 Municipal Investment Grant Program for contracting for the lease of Body Worn Cameras for the Town of Hyde Park Police Department for Police Reform.

RESOLUTION AUTHORIZING THE HIGHWAY SUPERINTENDENT TO CONSTRUCT FENCING ON THE EASTERN ENTRANCE TO THE DOCK STREET BRIDGE AND TO INSTALL SIGNS CLEARLY INDICATING THAT THE BRIDGE IS CLOSED TO VEHICULAR AND PEDESTRIAN TRAFFIC

WHEREAS, the stone masonry arch bridge over Crum Elbow Creek known as the Dock Street Bridge has, for several years, been in very poor condition to the extent that the structure is considered unstable and unsafe for both vehicular and pedestrian traffic; and

WHEREAS, the recent bridge inspection report prepared by the Federal Highway Administration has indicated that the bridge should be replaced or completely reconstructed and that in the interim vehicular and pedestrian access to the structure should also be prevented by the installation of permanent barriers; and

WHEREAS, currently pedestrian and vehicular traffic over the Dock Street Bridge is prevented solely by the placement of two sawhorses; and

WHEREAS, the Highway Superintendent has examined the site and has recommended that pedestrian and vehicular access over the bridge should be barred by the installation of fencing and the posting of signs advising the public that the bridge is closed to vehicular and pedestrian traffic.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby authorizes and directs the Town Highway Superintendent to install fencing across the eastside entrance to the Dock Street Bridge so as to prevent vehicular and pedestrian traffic over said bridge; and

BE IT FURTHER RESOLVED, that the Town Highway Superintendent is hereby authorized and directed to post signage at the site notifying the public that the bridge is closed for pedestrian and vehicular traffic.

RESOLUTION ADOPTING AMENDED VERSION OF LOCAL LAW NO. E OF THE YEAR 2021 IMPOSING A SIX-MONTH MORATORIUM ON THE PROCESSING AND APPROVAL OF APPLICATIONS FOR RURAL EVENT VENUES PURSUANT TO CHAPTER 108, §108-28, et. seq. OF THE TOWN CODE

WHEREAS, the Town Board had determined, upon the advice of its Zoning Administrator, that there may be some ambiguity in Chapter 108, §108-28, et. seq., of the Town Code with regard to Rural Event Venues and that there may be other sections of that portion of the Town Code which may be in need of amendment; and

WHEREAS, the Town Board had determined that the Rural Event Section of the Town Code needed to be reviewed and possibly amended, as appropriate; and;

WHEREAS, the Town Board directed its Planning Consultant and the Attorney to the Town to review the local law and provide recommendations for amendments to that section of the Town Code; and

WHEREAS, the Town Board has determined that such moratorium law is a Type II action, exempt from SEQRA review; and

WHEREAS, the Attorney to the Town prepared a six-month moratorium law providing for the moratorium on the processing and approval of applications for Rural Event Venues pursuant to Chapter 108, §108-28 et. seq. of the Town Code; and

WHEREAS, the Town Board determined that the enactment of the moratorium was required to provide the necessary time for the Town Board to review and to amend its Code with regard to Rural Event Venues; and

WHEREAS, the Town Board accepted Local Law No. E of the Year of 2021 entitled: “A Local Law Enacting a Six-Month Moratorium on the Processing and Approval of Applications for Rural Event Venues Pursuant to Chapter 108, §108-28 et. seq. of the Town Code” and scheduled a public hearing on said local law for May 3, 2021 at 6:05 p.m. at the Hyde Park Town Hall; and

WHEREAS, the Town Board directed the Town Clerk to publish notice and provide such other notice of said public hearing as may be required by law; and

WHEREAS, the Town Clerk was directed to forward a copy of said local law to the Town of Hyde Park Planning Board and to the Dutchess County Department of Planning and Development, as may be required by law, for their comments; and

WHEREAS, the Attorney to the Town, based upon further review of the original version of the proposed law, and after receiving comments from the Dutchess County Department of Planning and Development, has amended the Local Law to include, in relevant part, certain language concerning the length and details of the moratorium and a hardship waiver; and

WHEREAS, the Local Law as amended has been provided to the Town Board members and reviewed by the Town Board; and

WHEREAS, the Town Board at its May 17, 2021 meeting accepted the amended version of the proposed moratorium law and re-opened the public hearing for June 7, 2021 at 6:05 p.m.; and

WHEREAS, the Town Board hereby directed the Town Clerk to provide such posting and notice of said public hearing as required by law; and

WHEREAS, the Town Clerk forwarded a copy of this Resolution with the amended moratorium law to the Hyde Park Planning Board and Dutchess County Department of Planning and Development for additional comments, if any, and;

WHEREAS, per the Governor’s Executive Order, the meeting and public hearing will be held virtually with no gathering at the Town Hall and will be live streamed at on the Town of Hyde Park’s You Tube channel with the following link to review:

WHEREAS, the Town Board reopened the public hearing on June 7, 2021 and allowed for public comments and discussion and closed the public hearing on that same date.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby

adopts the amended version of the Local Law No. E of the Year 2021 imposing a six-month moratorium on the processing and approval of applications for Rural Event Venues pursuant to Chapter 108, §108-28, et. seq. of the Town Code; and

BE IT FURTHER RESOLVED, that this Local Law shall take effect immediately and that the Town Clerk is directed to file a copy of said Local Law with the Department of State, as required by law; and

BE IT FURTHER RESOLVED, that the Town Clerk is hereby directed to send a copy of said Moratorium Law to the Planning Board, Zoning Board of Appeals, Code Enforcement Officer, and Building Inspector.

TOWN OF HYDE PARK

LOCAL LAW 5 OF THE YEAR 2021

A LOCAL LAW ENACTING A SIX-MONTH MORATORIUM ON THE PROCESSING AND APPROVAL OF APPLICATIONS FOR RURAL EVENT VENUES PURSUANT TO CHAPTER 108, §108-28, et. seq., OF THE TOWN CODE

BE IT ENACTED by the Town Board of the Town of Hyde Park as follows:

SECTION 1. LEGISLATIVE INTENT.

The Town of Hyde Park adopted Chapter 108, Chapter 108-28, et. seq., of the Town Code by Local Law No. 10 of 2016 in or about November 28, 2016. It has come to the attention of the Town Board through the Town's Zoning Enforcement Officer that there may exist some ambiguities in the said Code provisions with regard to issues such as whether a rural event venue can be established in a newly constructed building or other structure. The Town Board has determined that there are other provisions of the rural event venue Code provision that may be in need of modification or amendment. The Town Board has determined that a six-month moratorium on the processing and approval of rural event venues is necessary in order to give the Town Board the necessary time to review the Code with its Town Planner and Attorney to the Town and determine if amendments to the Code are in the best interests of the Town and its residents. It is anticipated that the process will not take longer than six months. The enactment of this local law is designed to protect the health, safety and welfare of the Town of Hyde Park and its residents and maintain the status quo to allow the Town to study and make the required amendments to the Code for rural event venue facilities.

SECTION 2. MORATORIUM.

A. A moratorium is hereby imposed from the effective date of this Local Law for a period of six (6) months on the processing and/or approval of all applications for erection, construction, reconstruction, expansion, changing,

repairing, or structurally altering any rural event venue facilities pursuant to Article 108, Section 108.28 et. seq. within the Town.

B. The Zoning Administrator, Building Inspector and the Planning Board shall not consider applications for site plan review or special permit approval for rural event venues within the scope of this moratorium for the terms of this moratorium.

C. No building permit shall be issued pursuant to the Town of Hyde Park Zoning Code for construction of any rural event venue facility for the term of the moratorium.

SECTION 3. HARDSHIP WAIVER.

A. The Town Board may waive the provisions of the moratorium upon the application of an owner of property on which a rural event facility would have been a permitted principal, special permit or accessory use in the absence of this moratorium, provided that the applicant can demonstrate and the Town Board finds, based upon competent evidence and taking into account the impact of the relief on the health, safety, welfare, open space, rural character, scenic viewsheds and natural resources of the Town: (i) the application of this moratorium to the applicant's property will constitute an unjust result and cause the applicant substantial economic hardship; (ii) the proposed use of the property will not harm the public health, safety, and welfare; and (iii) the proposed use of the property is consistent with the Comprehensive Plan of the Town of Hyde Park and compatible with the existing land use in the immediate vicinity of the property. This application must comply with all other aspects of the Town of Hyde Park Code.

B. Upon submission of a written application to the Town Clerk by the property owner seeking a hardship waiver to this moratorium, the Town Board shall, within sixty (60) days of the receipt of such application, schedule a public hearing. Public notice of such hearing shall be given at least five (5) days prior to the date thereof in the official newspaper of the Town. At said public hearing, the property owner, and all other parties wishing to present evidence with regard to the application shall have an opportunity to be heard, and the Town Board shall within thirty (30) days of the close of said public hearing render its decision either granting, with, or without, conditions, or denying the application.

SECTION 4. STATEMENT OF AUTHORITY.

This Local Law is authorized by the New York State Constitution, Article IX, §2; the provisions of the New York State Municipal Home Rule Law (MHRL); the provisions of the Statute of Local Governments; all relevant provisions of the Town Law of the State of New York; the laws of the Town of Hyde Park and the general police powers vested in the Town of Hyde Park to promote the health, safety, and welfare of residents and property owners within the Town.

SECTION 5. SUPERSESION OF TOWN LAW.

Pursuant to the authority granted in the Municipal Home Rule Law, §1(ii)(b)(3) and in accordance with §22(1) of the MHRL, this Local Law supersedes §§267-a, 267-b, 274-a, 274-b, 276, 277 and 278 of the New York State Town Law.

SECTION 6. PENALTIES FOR VIOLATION.

In the event of a violation of this law, the penalties shall be those listed in the Town Code of the Town of Hyde Park for Zoning Code violations.

SECTION 7. SEVERABILITY.

The invalidity of any word, section, clause, paragraph, sentence, part, or provision of this Local Law shall not affect the validity of any other part of this Local Law, which shall be given effect without such part or parts.

SECTION 8. EFFECTIVE DATE.

This local law shall take effect immediately upon filing in the Office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

RESOLUTION AUTHORIZING THE IMPLEMENTATION, AND FUNDING IN THE FIRST INSTANCE 100% OF THE FEDERAL-AID (AND STATE “MARCHISELLI” PROGRAM-AID) ELIGIBLE COSTS, OF A TRANSPORTATION FEDERAL-AID PROJECT, AND APPROPRIATING FUNDS THEREOF

WHEREAS, a Project for the Route 9 Northbound Pedestrian Improvements – Park Plaza to Fire House, Town of Hyde Park, Dutchess County, PIN 876.90 (the “Project”) is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal funds and 20% non-Federal funds; and

WHEREAS, the Town of Hyde Park desires to advance the Project by making a commitment of 100% of the non-Federal share of the costs of right-of-way acquisition work.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Hyde Park Town Board does hereby approve the above-subject project; and

BE IT FURTHER RESOLVED, that the Hyde Park Town Board hereby authorizes the Town of Hyde Park to pay in the first instance 100% of the federal and non-federal share of the cost of right-of-way acquisition work the project or portions thereof; and

BE IT FURTHER RESOLVED, that the sum of \$100,630.00 is hereby appropriated pursuant to Resolution 1:22 – 2 of 2018 and made available to cover the cost of participation in the above phases of the project; and

BE IT FURTHER RESOLVED, that in the event the full Federal and non-Federal share costs of the Project exceeds the amount appropriated above, the Hyde Park Town Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Hyde Park Supervisor thereof; and

BE IT FURTHER RESOLVED, that the Hyde Park Town Supervisor be and is hereby authorized to execute all necessary agreements, certifications, or reimbursement requests for Federal Aid and/or applicable Marchiselli Aid on behalf of the Town of Hyde Park with the New York State Department of Transportation in connection with the advancement or approval of the project and providing for the administration of the project and the municipality’s first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible project costs and all project costs within appropriations therefore that are not so eligible; and

BE IT FURTHER RESOLVED, that in addition to the Town Supervisor, the following municipal titles: Deputy Supervisor, Comptroller, and Senior Account Clerk are also hereby authorized to execute any necessary agreements or certifications on behalf of the Municipality/Sponsor, with NYSDOT in

connection with the advancement or approval of the project identified in the State/Local Agreement; and

BE IT FURTHER RESOLVED, that a certified copy of this Resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary agreement in connection with the project; and

BE IT FURTHER RESOLVED, this Resolution shall take effect immediately.

WHEREAS, the Town of Hyde Park was required to close the Dock Street Bridge to vehicle and pedestrian traffic by the Federal Department of Transportation in 2012; and

WHEREAS, the Town does not have the necessary funds to undertake repair of said bridge; and

WHEREAS, on May 25, 2021 the Town Supervisor was informed of grant potential for repairs of the bridge through Senator Schumer's Congressionally Directed Spending for 2022 with required submission by 6:00 pm on May 26, 2021; and

WHEREAS, prior research provided a budget for repair or replacement of the bridge to be at least \$1.5 million with costs escalating 10% per year since that time.

NOW, THEREFORE, BE IT RESOLVED, the Town Supervisor is hereby authorized to submit nunc pro tunc, the Schumer Congressionally Directed Spending application to apply for a \$2,000,000 in appropriated funds for restoration of the Historic Dock Street Bridge.


