NOTICE OF PUBLIC HEARING & MONTHLY MEETING FAIRVIEW FIRE DISTRICT

PLEASE TAKE NOTICE that the Board of Fire Commissioners of the Fairview Fire District will convene on November 21st, 2023 starting at 6:00PM for a public information session on the proposed firehouse renovation project and the Monthly Board meeting.

The Fairview Fire District will hold a public information session at its November 21, 2023 meeting on the proposed renovation of the Fairview Firehouse and the proposed plan of financing that necessary work. At the District's annual election on December 12, 2023, a proposition will be put to eligible voters to authorize that work, at an estimated cost of \$9.6 million, which is to be paid for by \$800,000.00 from the Building Reserve Fund, and the issuance of bonds in an amount not to exceed \$8.8 million. As part of that session, the Board will hear public comment on the proposed project, and address any questions and comments that may be raised. In accordance with District policy, it is anticipated that this meeting will be conducted as a hybrid meeting, to the extent allowed by State law: Commissioners will be present in-person, staff and the public may attend the meeting in-person or virtually via the Zoom conferencing platform. In the event a Commissioner is unable to attend this meeting in-person due to extraordinary circumstances, notice of that Commissioner's intent to participate remotely will be given in accordance with the Open Meetings Law.
